# **Guests Brief**



## Lin William CONG

## Professor, Cornell University, United States

Professor Lin William Cong is currently the Distinguished Professor of Finance and Management at Cornell University and a senior scholar at the National Bureau of Economic Research (NBER). He also serves as a scientist at the

Institute for Cryptography and Smart Contracts, a special professor at Tsinghua and Peking Universities, and the dean of the Fudan-Stanford Research Institute of Financial Technology and Security. In academic management, he is the financial editor of the journal Management Science. He founded and established the Cornell Fintech Center, the Digital Finance and Technology Laboratory, the Cryptocurrency and Blockchain Economics Research Forum, and the Financial AI and Big Data Research Forum. He also serves as a senior scholar at the Asian Bureau of Finance and Economic Research (ABFER) and the founding director of the "Technology, Digital Markets, and Artificial Intelligence" department. Additionally, he serves as an advisory expert for several central, banks the International Monetary Fund (IMF), non-profit organizations, investment companies, unicorn enterprises, regulatory bodies, and entrepreneurial and innovative projects.



## Fouad Ben ABDELAZIZ

### **Professor, NEOMA Business School, France**

Dr. Fouad Ben Abdelaziz is currently a Distinguished Professor at NEOMA Business School, the director of the Master's program in Artificial Intelligence Business Applications and the Master's program in Supply Chain Management,

and the dean of the doctoral program. He obtained his Ph.D. in Operations and Decision Systems from Laval University in Canada and visited the Center for Operations Research at Rutgers University in New Jersey, USA, as a senior Fulbright scholar. As an authoritative scholar in the field of multi-objective stochastic optimization, his research results have been published in top journals such as the European Journal of Operational Research (EJOR), Annals of Operations Research (ANOR), and Fuzzy Sets and Systems (FSS). He has also served as a guest editor for special issues of several internationally renowned journals.



## Tariq MALIK

## Professor, Director, International Center for Organization & Innovation Studies, Singarpore

Professor Tariq Malik is an expert in the field of innovation and industrial economics. He has published numerous papers in journals such as Technological

Forecasting and Social Change, China Economic Review, and Technology Analysis & Strategic Management, focusing on university-industry cooperation and organizational issues in China's semiconductor industry.



## Tissa Ravinda PERERA Professor, University of Colombo, Sri Lanka

Professor Tissa Ravinda Perera is a distinguished scholar and expert in the field of management and organizational research. He currently leads the Doctor of Business Administration (DBA) and Master of Business Administration (MBA)

programs at the University of Colombo and the University of Kelaniya. He has also served as the head of the Department of Management and Organizational Research at the Faculty of Management and Finance at the University of Colombo. In addition to his work academic, Professor Perera is an experienced corporate trainer and business consultant. He has collaborated with well-known organizations such as the Chartered Institute of Personnel Management (CIPM) in Sri Lanka, the International Institute of Innovation and Knowledge Management (TIIKM), and McQuire Rens & Jones. He is currently a senior consultant at the Global Education and Training Institute (private) Limited and Global Consulting and Research Services. He has in-depth research in entrepreneurship, micro and small enterprise development, innovation, and management practices. He participated in the World Bank-funded AHEAD project, served as the president of the Faculty of Management and Finance Teachers' Association at the University of Colombo, and founded the Career Guidance Center of the faculty, serving as its first coordinator.



## **Khalid AHMED**

## Associated Professor, Australian National University, Australia

Associate Professor Khalid Ahmed is currently a visiting honorary researcher at the Australian National University and a full-time associate professor at the Institute of Policy Studies at University Brunei Darussalam, specializing in energy

and environmental economics. He has previously served as a full-time associate professor and director of the research center and behavioral laboratory at the Sukkur IBA University Business School in Pakistan. He has also visited and exchanged at the University of Cambridge in the UK, Monash University in Australia, and Xi'an Jiaotong University in China. He is among the top 2% of the world's most cited scholars according to Stanford University (2021-2023). He has received multiple awards for outstanding young scholars in higher education along the Belt and Road Initiative in China. He has also been awarded the Charles Wallace Scholarship from the University of Cambridge and the Erasmus Mundus World Plan Postdoctoral Fellowship from the European Union, among many other honors.



## HUA Junyi

## Assistant Professor, City University of Macau, Macao

Dr. Hua Junyi, an economics Ph.D. graduate from Ohio State University, is currently an assistant professor at the University of Macau. From 2020 to 2023,

she served as a research assistant in the USDA Thriving Agricultural Systems in Urbanized Landscapes project in the United States.
